Information About The Service

Fibre400/Fibre1000 IP-Line is a symmetrical fibre-optic connection to the iiNet network and includes unlimited internet at 400Mbps and 1000Mbps bandwidths respectively.

Requirements & Availability

Fibre400/Fibre1000 is limited to iiNet on-net buildings. Your address must be pre-qualified before a formal quotation can be provided.

You will require a compatible router or firewall at your premises. You can choose our managed router option in which case we will supply and manage the router for you.

Minimum Term

Fibre400 plans are available on a 24 or 36 month contract. Fibre1000 plans are available on a 24, 36 or 48 month contract.
