# **Information About The Service**

On-Net Fibre is a symmetrical 100Mbps fibre-optic connection to the iiNet network and includes unlimited internet.

#### Requirements & Availability

On-Net Fibre is limited to iiNet coverage areas. Your address must be pre-qualified before a formal quotation can be provided.

You will require a compatible router or firewall at your premises. You can choose our managed router option in which case we will supply and manage the router for you.

#### **Minimum Term**

On-Net Fibre plans are available on a 24 or 36 month contract. A 36 month contract gives you a \$0 activation fee, with more information in the Information About Pricing section below.

With On-Net Fibre, you can choose between a 24 or 36 month contract, with the 36 month contract giving you access to a \$0 activation fee as per the table below.

- The standard activation fee for On-Net Fibre is \$1,100.
- The Total Minimum Price on a 24 month contract is the standard \$1,100 activation fee plus 24 months of plan rental.

## **Cancellation Fee**
