Extreme weather events impact services in Kimberley, Darwin – Daly, Arnhem, Roper – McArthur and Victoria River regions of WA and NT iiNet Group reference ID: 1939966

The iiNet Group (iiNet Ltd, Westnet Pty Ltd, Netspace Pty Ltd, Internode Pty Ltd and the AAPT Consumer Division) is currently working to manage the impact to its network caused by extreme weather events in Kimberley, Darwin – Daly, Arnhem, Roper – McArthur and Victoria River regions of WA NT on or about Monday 12 March 2012 through to Thursday 15 March 2012.

Due to the effect of damage to the iiNet telecommunications network by extreme weather conditions, rendering some services faulty, as referred to in Telstra Wholesales Mass Service Disruption Notification which can be found at http://telstra.com.au/abouttelstra/commitments/mass-service-disruption/ a copy of this notice will also be published in the Northern Territory News and West Australian on Friday 23/03/2012.

The iiNet Group is working closely with suppliers and wholesalers to assess and repair the damage to affected services in a timely manner. Customers in these regions may experience service disruptions and delays to normal connection times and fault restoration.

Because these events are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply from **14th March 2012 to 23rd March 2012** inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
