Natural Disaster events impact services in the districts of Central West, South West, South Coastal, Great Southern and the Central Wheat Belt, WA iiNet Group reference ID: 1825271

The iiNet Group (iiNet Ltd, Westnet Pty Ltd, Netspace Pty Ltd and the AAPT Consumer Division) is currently working to manage the impact to its network caused by a Natural Disaster in Sydney on or about 6th December 2011.

Large hailstones, very heavy rainfall, flash flooding and damaging winds has caused notable damage to the network, rendering some services faulty, as referred to in Telstra Wholesales Mass Service Disruption Notification which can be found at http://telstra.com.au/abouttelstra/commitments/mass-service-disruption/ and will also be published in the West Australian on Monday 12th December 2011.

The iiNet Group is working closely with suppliers and wholesalers to assess and repair the damage to affected services in a timely manner. Customers in these regions may experience service disruptions and delays to normal connection times and fault restoration.

Because these events are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply from 6th December 2011 to 16th December 2011 inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
