Extreme weather events impact services in Southern Tablelands and ACT Districts

The iiNet Group (iiNet Ltd, Westnet Pty Ltd, Netspace Pty Ltd and the AAPT Consumer Division) is currently working to manage the impact to its network caused by extreme weather events in Southern Tablelands and ACT Districts on or about Friday 20th January 2012.

Because these events are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply from 23rd January 2012 to 17th February 2012 inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
