The iiNet Group (iiNet Ltd, Westnet Pty Ltd, Netspace Pty Ltd, Internode Pty Ltd, AAPT Consumer Division and TransACT Capital Communications Pty Ltd) is currently working to manage the impact to its network that has occurred as a result of extreme weather events in the Eastern Eyre Peninsula, Flinders, Mid North, Riverland, Murraylands, Mount Lofty Ranges and Upper Southeast region of South Australia on or about Friday 30 November 2012.

Severe thunderstorms have caused notable damage to the network, rendering some services faulty, as referred to in Telstra Wholesales Mass Service Disruption Notification which can be found at http://telstra.com.au/abouttelstra/ commitments/mass-service-disruption/ a copy of this notice will also be published in the **Adelaide Advertiser on 7 December 2012.**

Because these events are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply from **3 December 2012 to 14 December 2012** inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
