Extreme Weather events impact service in Pilbara District

iiNet Group reference ID: 2441903

The iiNet Group (iiNet Ltd, Westnet Pty Ltd, Netspace Pty Ltd, Internode Pty Ltd, AAPT Consumer Division and TransACT Capital Communications Pty Ltd) is currently working to manage the impact to its network that has occurred as a result of extreme weather events caused by Tropical Cyclone Rusty in the Pilbara region of Western Australia on or about Monday 25 February 2013 through to Thursday 28 February 2013.

Tropical Cyclone Rusty has caused notable damage to the network, rendering some services faulty, as referred to in Telstra Wholesales Mass Service Disruption Notification which can be found at <http://telstra.com.au/abouttelstra/commitments/mass-service-disruption/> a copy of this notice will also be published in the **West Australian on the 5 March 2013**.

The iiNet Group is working closely with suppliers and wholesalers to assess and repair the damage to affected services in a timely manner. Customers in these regions may experience service disruptions and delays to normal connection times and fault restoration.

Because these events are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply from **25 February 2013 to 22 March 2013** inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
