

# CUSTOMER SERVICE NOTICE FROM IINET GROUP

## Extreme Weather events impact service in Victoria and the South Coast, South West Slopes, Riverina, and Lower Western districts of New South Wales

iiNet Group reference ID: 2602659

As previously notified on 7 June 2013, the iiNet Group (iiNet Ltd, Westnet Pty Ltd, Internode Pty Ltd, AAPT Consumer Division and TransACT Capital Communications Pty Ltd) is currently working to manage the impact to its network that has occurred as a result of extreme weather events in Victoria and the South Coast, South West Slopes, Riverina, and Lower Western districts of New South Wales on or about Friday 31 May 2013 through to Saturday 1 June 2013.

Heavy rain, lightning and flash flooding have caused notable damage to the network, rendering some services faulty, as referred to in Telstra Wholesales Mass Service Disruption Notification which can be found at <http://telstra.com.au/abouttelstra/commitments/mass-service-disruption/>. A copy of this notice will also be published in the **Herald Sun** on **9 July 2013** and **Daily Telegraph** on **10 July 2013**.

The iiNet Group is working closely with suppliers and wholesalers to assess and repair the damage to affected services in a timely manner. Customers in these regions may experience service disruptions and delays to normal connection times and fault restoration. The impact in the affected region has been greater than initially estimated, and as a consequence the expected date for resumption of normal service operations has been extended to **2 August 2013**.

As these circumstances are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply from **1 June 2013 to 2 August 2013** inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
