## Extreme Weather events impact service in Pilbara District.

The iiNet Group (iiNet Ltd, Westnet Pty Ltd, Internode Pty Ltd, AAPT Consumer Division and TransACT Capital Communications Pty Ltd) is currently working to manage the impact to its network that has occurred as a result of extreme weather events in the Pilbara region of WA on or about Tuesday 25 June 2013.
