The iiNet Group (iiNet Ltd, Westnet Pty Ltd, Internode Pty Ltd, AAPT Consumer Division and TransACT Capital Communications Pty Ltd) is currently working to manage the impact to its network that has occurred as a result of extreme weather events in the Adelaide, Greater Adelaide, Flinders, Mid North, Yorke Peninsula, Kangaroo Island, Mount Lofty Ranges, Upper South East and Lower South East Districts of South Australia on or about Thursday 18 Iuly 2013 and Monday 22 Iuly 2013.

The iiNet Group is working closely with suppliers and wholesalers to assess and repair the damage to affected services in a timely manner. Customers in these regions may experience service disruptions and delays to pormal connection times and fault restoration.
