

CUSTOMER SERVICE NOTICE FROM iiNET GROUP

Extreme Weather events impact service in South Coast and Illawarra Districts of New South Wales and Australian Capital Territory District

iiNet Group reference ID: **2794277**

The iiNet Group (iiNet Ltd, Westnet Pty Ltd, Internode Pty Ltd, AAPT Consumer Division, TransACT Capital Communications Pty Ltd and Jiva Pty Ltd) is currently working to manage the impact to its network that has occurred as a result of a series of extreme weather events in the South Coast and Illawarra Districts of New South Wales and Australian Capital Territory District on or about Monday 16 September 2013 through to Tuesday 17 September 2013.

Damaging winds, heavy rain and flash flooding have caused notable damage to the network, rendering some services faulty, as referred to in Telstra Wholesales Mass Service Disruption Notification which can be found at <http://telstra.com.au/abouttelstra/commitments/mass-service-disruption/>. A copy of this notice will also be published in the **Daily Telegraph on 23 September 2013**.

The iiNet Group is working closely with suppliers and wholesalers to assess and repair the damage to affected services in a timely manner. Customers in these regions may experience service disruptions and delays to normal connection times and fault restoration.

As these circumstances are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply from **17 September 2013 to 11 October 2013** inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
