

CUSTOMER SERVICE NOTICE FROM iiNET GROUP

Extreme Weather events impact service in Pilbara, North and South Interior Districts of Western Australia.

iiNet Group reference ID: 2993827

The iiNet Group (iiNet Ltd, Westnet Pty Ltd, Internode Pty Ltd, AAPT Consumer Division, TransACT Capital Communications Pty Ltd and Jiva Pty Ltd) is currently working to manage the impact to its network that has occurred as a result of a series of extreme weather events resulting from Tropical Cyclone Christine in the Pilbara, North and South Interior regions of Western Australia on or about Sunday 29 December 2013 through to Tuesday 31 December 2013.

Heavy rainfall, very destructive wind, very dangerous storm tide, damaging waves, and very dangerous coastal inundation have caused notable damage to the network, rendering some services faulty, as referred to in Telstra Wholesales Mass Service Disruption Notification which can be found at <http://telstra.com.au/abouttelstra/commitments/mass-service-disruption/>. A copy of this notice will also be published in the **West Australian on 6 January 2014**.

The iiNet Group is working closely with suppliers and wholesalers to assess and repair the damage to affected services in a timely manner. Customers in these regions may experience service disruptions and delays to normal connection times and fault restoration.

As these circumstances are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply from **30 December 2013 to 31 January 2014** inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
