

Customer Service Notice from iiNet Group

Extreme Weather events impact service in Adelaide Metropolitan, Mount Lofty Ranges and Murraylands Districts of South Australia.

iiNet Group reference ID: 3601269

The iiNet Group (iiNet Ltd, Westnet Pty Ltd, AAPT Consumer Division, Internode Pty Ltd, TransACT Capital Communications Pty Ltd, Jiva Pty Ltd and Adam Internet Pty Ltd) is currently working to manage the impact to its network that has occurred as a result of a series of extreme weather events in the Adelaide Metropolitan, Mount Lofty Ranges and Murraylands regions of South Australia on or about Sunday 26 October 2014.

Severe thunderstorms and lightning have caused notable damage to the network, rendering some services faulty, as referred to in Telstra Wholesales Mass Service Disruption Notification which can be found at <http://telstra.com.au/abouttelstra/commitments/mass-service-disruption/>. A copy of this notice will also be published in the **Adelaide Advertiser** on **3 November 2014**.

The iiNet Group is working closely with suppliers and wholesalers to assess and repair the damage to affected services in a timely manner. Customers in these regions may experience service disruptions and delays to normal connection times and fault restoration.

As these circumstances are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply from **27 October 2014 to 16 November 2014** inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
