

Customer Service Notice from iiNet Group

Ongoing Extreme Weather events impact service in Northern Rivers, Northern Tablelands, North West Slopes and Plains and part of the Mid North Coast of New South Wales

iiNet Group reference ID: 3703561

As previously notified on **15 December 2014** and **13 January 2015**, the iiNet Group (iiNet Ltd, Westnet Pty Ltd, AAPT Consumer Division, Internode Pty Ltd, TransACT Capital Communications Pty Ltd, Jiva Pty Ltd and Adam Internet Pty Ltd) is currently working to manage the impact to its network that has occurred as a result of ongoing extreme weather events in the Northern Rivers, Northern Tablelands, North West Slopes and Plains and part of the Mid North Coast of New South Wales on or about Friday 5 December 2014 continuing to date.

Destructive wind, large hailstones and flash flooding have caused notable damage to the network, rendering some services faulty, as referred to in Telstra Wholesales Mass Service Disruption Notification which can be found at <http://telstra.com.au/abouttelstra/commitments/mass-service-disruption/>. A copy of this notice will also be published in the **Sydney Daily Telegraph on 10 February 2015**.

The iiNet Group is working closely with suppliers and wholesalers to assess and repair the damage to affected services in a timely manner. Customers in these regions may experience service disruptions and delays to normal connection times and fault restoration. The impact in the affected region has been greater than initially estimated and as a consequence of the ongoing weather effects, the expected date for resumption of normal service operations has been extended to **8 March 2015**.

As these circumstances are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply from **9 December 2014 to 8 March 2015** inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
