

Customer Service Notice from iiNet Group

Extreme Weather events impact service in Daly, Tiwi and Arnhem Districts of the Northern Territory. iiNet Group reference ID: 3855259

As previously notified on **2 March 2015**, the iiNet Group (iiNet Ltd, Westnet Pty Ltd, AAPT Consumer Division, Internode Pty Ltd, TransACT Capital Communications Pty Ltd, Jiva Pty Ltd and Adam Internet Pty Ltd) is currently working to manage the impact to its network that has occurred as a result of a series of extreme weather events in the Daly, Tiwi and Arnhem Districts of Northern Territory on or about Monday 16 February 2015 through to Sunday 22 February 2015.

Tropical Cyclone Lam has caused notable damage to the network, rendering some services faulty, as referred to in Telstra Wholesales Mass Service Disruption Notification which can be found at <http://telstra.com.au/abouttelstra/commitments/mass-service-disruption/>. A copy of this notice will also be published in the **Northern Territory News** on **25 March 2015**.

The iiNet Group is working closely with suppliers and wholesalers to assess and repair the damage to affected services in a timely manner. Customers in these regions may experience service disruptions and delays to normal connection times and fault restoration. The impact in the affected region has been greater than initially estimated and as a consequence of the continued weather effects, the expected date for resumption of normal service operations has been extended to **12 April 2015**.

As these circumstances are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply from **23 February 2015 to 12 April 2015** inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
