## Severe weather events impact services in Perth and Lower West Districts and parts of the Central Wheat Belt, Great Southern and South West Districts of Western Australia. iiNet Group reference ID: 3941853

The iiNet Group (iiNet Ltd, Westnet Pty Ltd, AAPT Consumer Division, Internode Pty Ltd, TransACT Capital Communications Pty Ltd, Jiva Pty Ltd and Adam Internet Pty Ltd) is currently working to manage the impact to its network that has occurred as a result of extreme weather events in the Perth and Lower West Districts and parts of the Central Wheat Belt, Great Southern and South West Districts of Western Australia on or about Thursday 9 April 2015.

Heavy rainfall and damaging winds have caused notable damage to the network, rendering some services faulty, as referred to in Telstra Wholesales Mass Service Disruption Notification which can be found at http://telstra.com.au/abouttelstra/commitments/mass-service-disruption/. A copy of this notice will also be published in the West Australian on 17 April 2015.

The iiNet Group is working closely with suppliers and wholesalers to assess and repair the damage to affected services in a timely manner. Customers in these regions may experience service disruptions and delays to normal connection times and fault restoration.

As these circumstances are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply 13 April 2015 to 10 May 2015 inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
