

Customer Service Notice from iiNet Group

Staff Redeployment impact service in parts of South West District of Western Australia.

iiNet Group reference ID: 4040745

The iiNet Group (iiNet Ltd, Westnet Pty Ltd, AAPT Consumer Division, Internode Pty Ltd, TransACT Capital Communications Pty Ltd, Jiva Pty Ltd and Adam Internet Pty Ltd) is currently working to manage the impact to its network that has occurred as a result of Telstra wholesale staff being redeployed on or about 18 May 2015.

Destructive and damaging winds, heavy rainfall and damaging surf have caused notable damage to the network in widespread areas of coastal New South Wales. Due to the extent and severity of these ongoing weather events, our wholesaler has redeployed staff from across Australia as referred to in Telstra Wholesales Mass Service Disruption Notification which can be found at <http://telstra.com.au/abouttelstra/commitments/mass-service-disruption/>. A copy of this notice will also be published in the **West Australian** on **22 May 2015**.

The iiNet Group is working closely with suppliers and wholesalers to assess and manage the impact to affected services in a timely manner. Customers in South West District of Western Australia may experience service disruptions and delays to normal connection times and fault restoration as Telstra wholesale staff from this region are redeployed to coastal New South Wales. As these circumstances are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply from **18 May 2015 to 14 June 2015** inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
