Severe Weather events impact service in the Illawarra District and parts of the South Coast and Southern Tablelands and the Australian Capital Territory.

The iiNet Group (iiNet Ltd, Westnet Pty Ltd, Internode Pty Ltd, TransACT Capital Communications Pty Ltd and Adam Internet Pty Ltd) is currently working to manage the impact to its network that has occurred as a result of a series of severe weather events in the Illawarra District and parts of the South Coast and Southern Tablelands and the Australian Capital Territory on or about Saturday 4 June 2016 through to Monday 6 June 2016.

Destructive winds, heavy rainfall and abnormally high tides have caused notable damage to the network, rendering some services faulty, as referred to in Telstra Wholesales Mass Service Disruption Notification which can be found at http://telstra.com.au/abouttelstra/commitments/mass-service-disruption/. A copy of this notice will also be published in the **Sydney Daily Telegraph** on **15 June 2016**.

The iiNet Group is working closely with suppliers and wholesalers to assess and repair the damage to affected services in a timely manner. Customers in these regions may experience service disruptions and delays to normal connection times and fault restoration.

As these circumstances are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply from 6 June 2016 to 10 July 2016 inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
