## Extreme Weather events impact service in the Adelaide Metropolitan Area.

## iiNet Group reference ID: 4803421

As previously notified on 30 June 2016 the iiNet Group (iiNet Ltd, Westnet Pty Ltd, Internode Pty Ltd, TransACT Capital Communications Pty Ltd and Adam Internet Pty Ltd) is currently working to manage the impact to its network that has occurred as a result of a series of extreme weather events in the Adelaide Metropolitan area of South Australia on or about Thursday 23 June 2016 through to Friday 24 June 2016.

Damaging winds and heavy rainfall have caused notable damage to the network, rendering some services faulty, as referred to in Telstra Wholesales Mass Service Disruption Notification which can be found at http://telstra.com.au/abouttelstra/commitments/mass-service-disruption/. A copy of this notice will also be published in the **Adelaide Advertiser** on **21 July 2016**.

The iiNet Group is working closely with suppliers and wholesalers to assess and repair the damage to affected services in a timely manner. Customers in these regions may experience service disruptions and delays to normal connection times and fault restoration. The impact in the affected region has been greater than initially estimated and as a consequence of the extent of damage to the network, the expected date for resumption of normal service operations has been extended to **31July 2016**.

As these circumstances are outside the iiNet Group's control, iiNet is claiming an exemption under Section 21 of the Telecomm unications (Customer Service Guarantee) Standard 2011 from the normal performance standards. The exemption shall apply from **24June 2016** to **31July 2016** inclusive. This date is indicative only; customers should anticipate that some further delays may occur.
