# AUSTRALIAN TELECOMMUNICATIONS INDUSTRY UNITES ON COPYRIGHT PROTECTION PLAN

The Australian telecommunications industry has proposed a united plan to protect online copyright and educate consumers about appropriate use online content.

Communications Alliance, Australia's primary telecommunications industry body, today released a detailed industry-led scheme to address online copyright infringement.

Australia's second largest DSL broadband provider, iiNet, welcomed the release of the proposal saying it outlined a commonsense, effective and appropriate scheme to protect copyright, educate consumers and change infringing behaviour.

iiNet Chief Executive Officer Michael Malone said increasing lawful online content in a more timely, affordable and competitively priced along with protecting content owners copyright remains an important issue for the entire industry.

"I have consistently said that a whole-of-industry plan based on a clear and evidence-based approach was the best way forward," Mr Malone said.

"This paper and proposal provides that."

"The plan to conduct an 18 month trial involving warnings to alleged infringing customers and the ability for rights holders to take court action along with a detailed independent evaluation strikes the right balance."

He said many elements of the proposal were consistent with the position iiNet had been advocating for many years and to their <u>paper</u> released earlier this year calling for more legal content online and proposing a balanced enforcement regime.
